

# Who We Are

### Cherry Health

Cherry Health is an independent, non-profit Federally Qualified Health Center (FQHC) with a primary focus of providing high quality health services to those who have little or no access to health care, regardless of income or insurance status.

A sliding fee payment scale based on income and family size is available to those without insurance. Medicaid and Healthy Michigan are accepted, as are many other insurances.

Established in 1988, Cherry Health is the largest FQHC in the State of Michigan serving Barry, Eaton, Kent, Montcalm, Muskegon, Ottawa and Wayne counties. Providing integrated health care services at more than 20 locations throughout Michigan, Cherry Health employs approximately 900 employees and a network of over 60 physicians and mid-level providers specializing in primary care/family medicine, pediatrics, internal medicine, obstetrics/gynecology, optometry, oral health, behavioral health and substance use disorders. Additionally, Cherry Health runs a school linked program active in 70 public schools offering both vision and dental care. Michigan's largest Federally Qualified Health Center



Our community will be healthier because we will seek out and welcome those who need our services. All will be treated as family with integrated, coordinated care to improve health and personal well-being.




# 2017 Visits






### **FY2018 Revenue Sources**

### Total Revenue: \$84,625,325




### Advocacy and Engaging in Public Policy at Cherry Health










# Barry Community Health Center Patients by Payer Type





FAQ Contact	<b>Background:</b> Community Health Centers (CHCs) are the nation's largest and fastest growing network of primary care (PC) clinics. There are 1,200 CHCs that provide clinical services to 21 million rural, low income and minority Americans every year.
	As a result, the prevalence of mental health disorders is substantially higher than in private practice. CHC patients often have complex mental health problems such as Post-traumatic Stress Disorder (PTSD) and Bipolar Disorder, putting them at risk for significantly worse educational attainment, lower family, social and occupational functioning, and significantly lower quality of life. However, the vast majority of CHCs do not have psychiatrists or psychologists practicing on site. PTSD and Bipolar Disorder are devastating MH disorders that often go undetected and untreated – PTSD and Bipolar Disorder are among the biggest contributors to disability/suicidality worldwide. While there are highly effective treatments for PTSD and Bipolar Disorder, rural CHC patients do not have access to these treatments.

Short Title: PIPBHC

#### Description

The Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Mental Health Services (CMHS), is accepting applications for fiscal year (FY) 2017 Promoting Integration of Primary and Behavioral Health Care (Short Title: PIPBHC) Cooperative Agreements. The purpose of this cooperative agreement is to: (1) promote full integration and collaboration in clinical practice between primary and behavioral healthcare; (2) support the improvement of integrated care models for primary care and behavioral health care to improve the overall wellness and physical health status of adults with a serious mental illness (SMI) or children with a serious emotional disturbance (SED); and (3) promote and offer integrated care services related to screening, diagnosis, prevention, and treatment of mental and substance use disorders, and co-occurring physical health conditions and chronic diseases. SAMHSA expects that a continuum of prevention, treatment and recovery support services will be offered to consumers within the PIPBHC grant program.
